WORK PERFORMED THIS QUARTER (Second Quarter 2007):

1. Prepared and submitted the First Quarter 2007 Status Report.

2. Performed offsite ground-water investigation, across Park Boulevard from Site, within City of Oakland right-of-way. Work performed by Stratus Environmental Services, Inc. (Stratus) on 25 June 2007.

WORK PROPOSED FOR NEXT QUARTER (Third Quarter 2007):

- 1. Prepared and submitted this Second Quarter 2007 Status Report (contained herein).
- 2. Prepare Offsite Soil & Ground-Water Investigation Report following results availability.

DISCUSSION:

On 25 June 2007, Stratus and RSI Drilling executed the offsite soil and ground-water Hydropuch boring investigation, in accordance with the *Work Plan Addendum for Offisite Investigation*, submitted by URS on 5 April 2005 and approved by Alameda County Environmental Health in the letter dated 16 October 2006. Work had been delayed for some time due to encroachment issues with the City of Oakland and proximity to high-consequence underground utilities. In the meantime, it had been evaluated but decided against drilling into the base of a small hillside over and behind a short concrete-block retaining wall on property owned by the Oakland High School/Oakland Unified School District.

In accordance with the proposed plan, Hydropunch borings were advanced in four areas across Park Boulevard from the Site. Two borings were advanced at each location to log lithology and collect soil samples, as well as to collect a total of seven depth-discrete ground-water Hydropunch samples. The approximate locations of the Hydropunch boring locations are shown in Drawing 1. Due to the late date of the boring investigation, results are not available to provide herein. The actual boring locations and results of the investigation will be presented within the third quarter, following analysis of the field and laboratory data and preparation of the subsequent Offsite Soil & Ground-Water Investigation report.
