### **WORK PERFORMED THIS QUARTER (Third Quarter 2008):**

1. Prepared and submitted the Second Quarter 2008 Status Report.

- 2. Prepared and submitted the Work Plan for Ground-Water Investigation (BAI, 9/2/2008).
- 3. No environmental field work was conducted at the Site during the Third Quarter of 2008.

## **WORK PROPOSED FOR NEXT QUARTER (Fourth Quarter 2008):**

- 1. Prepared and submitted this Third Quarter 2008 Status Report (contained herein).
- 2. Work with the City of Oakland on an encroachment permit to facilitate installation of off-site wells proposed in the Work Plan for Ground-Water Investigation. Once permit is issued, field activities associated with the investigation will be completed.

#### **DISCUSSION:**

On 2 September 2008, BP submitted a Work Plan for Ground-Water Investigation in accordance with a directive request from ACEH dated 7 July 2008. Mr. Paresh Khatri of ACEH approved the aforementioned work plan in a response letter dated 17 September 2008. A site map displaying the proposed drilling/monitoring well locations from the approved work plan is provided as Drawing 1.

Communication with the City of Oakland on approval of a permit for installation of proposed off-site wells within the sidewalk to the north and across Park Boulevard has been initiated. The City of Oakland indicated a formal permit application would be considered; however, that it may take up to eight weeks to review the application. Accordingly, deadlines originally specified in the ACEH 17 September 2008 letter are not achievable. Because of uncertainty in timing for installation of off-site wells, BAI requested in an email dated 13 October 2008 that project deadlines not be specified at this time. The ACEH approved this request in their 14 October 2008 email. Per ACEH's request, all correspondence with the City of Oakland regarding off-site access will by copied to the ACEH.
