Thanks for the email.

The last we talked, I believe we discussed going back to the original approach of placing the summa canisters in the elevator sumps. Our approach will be to place and retrieve the summas using either an attached cord or some sort of hooking device (without personnel entering into the sumps). We will be able to determine the best method for placement/retrieval once we perform the initial site visit/survey and further understand the sump details. Right now we are having difficulty getting the elevator operators to contract with Arcadis – we hope to get a resolution to this issue soon and will let you know as soon as we are able to schedule the site activities.

Mark,

I wanted to followup on the attached Request for Funds that was sent in early late August, as ACEH has not received a check to allow oversight of the environmental case. Because the subject site is not in the UST program, oversight costs must be recovered directly from identified responsible parties. Chevron has been the lead RP at the site.

I also wanted to followup on the status of garage vapor sampling in or around the elevator. We last discussed a response by Chevron by October 30th, now several weeks past.

It also looks like I may owe you an extension for the report submittal due to the need to identify a methodology for vapor sampling in the elevator pit. Part of the timing associated with the extension requires a response regarding the methodology.
