Ladies and Gentlemen:

Gribi Associates is pleased to submit this report documenting recent Phase I activities and including a workplan addendum to conduct additional investigation activities at the former Coast Sausage Company underground storage tank (UST) site at 1173 28th Street in Oakland, California (see Figure 1 and Figure 2). Phase I activities reported herein include: (1) Review of historical records for the project site and site vicinity; and (2) Review of hazardous waste site records for the site and site vicinity. The purpose of these Phase I activities was to assess possible sources for halogenated volatile organic compounds (HVOCs) encountered near the south project site property boundary. This report also includes a workplan addendum amending the original April 11, 2006 *Workplan to Conduct Site Characterization Activities*, proposing the drilling and sampling of five additional soil borings in Adeline Street south from the project site to assess offsite HVOC sources.

Note that, as part of this assessment, Gribi Associates conducted an inspection of the Adeline Street properties adjacent to the project site to assess utility locations in Adeline Street. Results of this inspection are summarized in Figure 3.

HISTORICAL RECORDS REVIEW

The historical records review consisted of a search of available public records to help establish the known past history of the site, and to determine whether obvious recognized environmental conditions have occurred in connection with the project site or properties adjacent to the project site.

Historical Sanborn Maps Review

Gribi Associates obtained copies of Sanborn Fire Insurance Maps for the project site from Environmental Data Resources (EDR) for years 1902, 1912, 1952, 1954, 1959, 1962, 1967, and 1970. Copies of these maps are included in Appendix A. Review of these Sanborn maps revealed the following:

- The project site is shown with one residential dwelling on the 1902 map and with two residential dwellings on the 1912 map. Surrounding properties are undeveloped or are developed as residences.
- On the 1952, 1954, and 1959 maps, the north portion of the site is fully covered with the original pre-fire project site building and is labeled as “Holly Meat Packing, Whol. Meats & Pack’g, Sausage Fackty”. The southwest portion of the site is covered with a building labeled as “Aluminum Casting”, at 2700 Magnolia Street. This aluminum casting building is also shown on the 1962 map, but is replaced by a parking lot on the 1967 and 1970 maps.
- On maps from 1959 to 1970, a Machine Shop is shown approximately 50 feet south of the east side of the project site, at 2701 Adeline Street.
- On maps from 1952 to 1970, Laher Spring & Tire Corp. is shown approximately 50 to 100 feet south from the project site, at 2639 Adeline Street/2650 Magnolia Street. The building adjacent to Adeline Street, at 2639 Adeline Street, is labeled as “Brake Shoe Rebonding Dept”.
- The property at 2601 Adeline, located approximately 100 feet south from the project site, is labeled as Kraft Foods Company on the 1952 and 1954 maps, as “Fire Ruins” on the 1959 map, and as a “Rag Cleaning W’ks,” on the 1962, 1967, and 1970 maps.
- A “Test Lab.” is shown immediately east across Adeline Street, at 2722 Adeline Street, on the 1967 and 1970 maps.

City Directory Review

A review of Polk and Haines city directories for years ranging from 1920 to 2006 were obtained from EDR. These directories provide tenant names for given street addresses. Review of selected city directories revealed the following:

- The 1173 28th Street project site address is listed as Bastian & Richards Wholesale Meats in the 1943 directory, and as Coast Sausage in directories from 1980 to 1992.
- The 2736 Magnolia Street project site address is listed as Ambassador Laundry Company in the 1925 directory, as Holly Meat Packing Company in directories from 1943 to 1970,

as Beta Sales Institutional Food Broker in the 1991 directory, and as La Coste Meat Company in the 1992 directory.

- The 2700 Magnolia Street project site address is listed as Leon Cameto Brass Foundry in the 1933 and 1943 directories, and as Production Foundry Company and Production Castings in directories from 1938 to 1955.
- The adjacent south parcel, at 2711 Adeline Street, is listed as Mist O2 Generating Equipment in directories from 1967 to 1975.
- The property at 2601 Adeline, located approximately 100 feet south from the project site, is listed as Kraft Foods in directories from 1938 to 1955, as East Bay Sanitary Rag Works in directories from 1962 to 1986, and as multiple construction-related tenants in directories from 1991 to 2000.
- Laher Spring & Electric Company is listed at 2615 Magnolia Street, west across Magnolia Street from the project site (but also apparently occupying a portion of the property immediately south from the project site) in directories from 1933 to 1967.

Historical Aerial Photographs Review

Historical aerial photos from 1931, 1939, 1946, 1958, 1965, 1982, 1993, and 1998 were obtained from EDR. Copies of selected aerial photos are contained in Appendix B. Information obtained from the aerial photos review is summarized in Table 1.

Oakland Planning Department Records Review

Mr. Jim Gribi of Gribi Associates reviewed City of Oakland Planning Department records for sites to the south of the project site (2601 Adeline Street, 2639 Adeline Street/2650 Magnolia Street, and 2701/11 Adeline Street) on January 10, 2007. Results of this records review are summarized below.

- **2601 Adeline Street:** Records indicate that this site, located approximately 100 feet south from the east portion of the project site, was occupied by Kraft Foods and Kraft Cheese Company from at least 1936 to 1959. A fire apparently destroyed the interior of the building in 1959. East Bay Sanitary Rag Works applied for building permits in 1959 and 1960 to construct a clerk’s office and repair the fire-damaged roof, respectively. The facility apparently included a “processing plant”, and two dryers were installed in 1975.
- **2639 Adeline Street/2650 Magnolia Street:** Records indicate that this property, located immediately south of the project site, was occupied by Laher Spring & Tire Company in the 1950s and 1960s. A 1953 record lists the site use as “bonding brake linings to break shoes.”
- **2701/2711 Adeline Street:** Records indicate that this property was occupied by CSB Construction Company in 1963.

Interviews with Knowledgeable Persons

Mr. Ed Gonsalves, the previous owner/operator of Coast Sausage for at least 20 years, stated that his operation was inspected by USDA inspectors regularly and that it did not include the use of solvents or other hydrocarbon products. He further indicated that the East Bay Sanitary Rag



Works, which was present at 2601 Adeline Street when he occupied the project site, included an industrial rag cleaning and delivery operation, and, as such, did include dry cleaning.

HAZARDOUS WASTE SITE RECORDS REVIEW

Gribi Associates reviewed hazardous waste information from the following governmental agency sources: (1) Federal lists; and (2) State and regional lists. The purpose of this review was to provide information about reported hazardous waste sites and incidents in the project site vicinity. In order to facilitate our review of Federal, State and regional lists, Gribi Associates obtained and reviewed a radius site profile for the project site area from Environmental Data Resources, Inc. (EDR). The EDR report includes a computer-generated search of the following regulated hazardous waste site lists within a specified radius from the project site. The executive summary and relevant portions of the EDR report are contained in Appendix C.

The project site is included on the CHMIRS, ERNS, and CS lists. The CHMIRS and ERNS listings refers to minor ammonia releases during a fire at the Coast Sausage facility in 1993. The CS is an Alameda County listing referring to the fuel USTs which were formerly located on the project site. This County leaking UST listing has been investigated and, as summarized in the August 2006 SWI report, does not pose a significant risk for the planned residential redevelopment of the site.

A review of the EDR report indicates one site in a possible expected upgradient groundwater flow direction which may have used HVOCs in the past. This site, Aerovoe Pacific, is located approximately 500 feet south from the project site at 2528 Adeline Street. According to its website, Aerovoe Industries has been a manufacturer of paints, specialty coatings, cleaners, lubricants, and other products for over 35 years. This site is included on the LUST, Cortese, CA FID UST, CS, and SWEEPS UST lists. These listings all refer to the operation of USTs to store V, M & P Naptha and Diesel fuel.

WORKPLAN ADDENDUM

Evaluation of Historical Records Review

Base on our review of available historical records, it appears that the most likely source of the chlorinated solvents (HVOC) groundwater impacts on the extreme southeast side of the project site is the former East Bay Sanitary Rag Works, which occupied the property at 2601 Adeline Street, approximately 100 feet south from the project site, from about 1959 to 1986.

Alternatively, a machine shop formerly located immediately south from the site could be a source for these HVOC impacts. Another possible offsite HVOC source is the former Aerovoe Pacific site, located approximately 500 feet south from the project site at 2528 Adeline Street, which may have included the manufacturing of paints, specialty coatings, cleaners, and lubricants. While these sites are not located in an expected upgradient groundwater flow

direction from the identified HVOC impacts on the project site, it is possible that underground utilities, which run along Adeline Street, could act as preferential migratory pathways for the HVOCs.

PROPOSED SCOPE OF WORK

In order to assess possible offsite HVOC sources, this workplan proposes the drilling and sampling of five soil borings in the Adeline Street parking lane.

Prefield Activities

Prior to implementing field activities, soil boring permits will be obtained from Alameda County Department of Public Works and notification will be given at least 72 hours prior to drilling. Necessary encroachment permits will be obtained for those borings to be drilled on public right-of-ways.

Prior to drilling, soil boring locations will be marked with white paint and USA will be notified. Also, a private utility locator will identify all utilities, which could represent HVOC migratory pathways.

Prior to drilling, site specific Health and Safety Plan will be issued to all site workers and a tailgate meeting conducted prior to beginning field work

Soil and Groundwater Sampling

Approximately five soil borings, GA-12 through GA-16, will be drilled to a depth of about 12 feet below surface (first encountered groundwater) using direct-push coring equipment (see Figure 3). Two of the soil borings, GA-12 and GA-13, will be located on the east side of Adeline Street, south of previous boring GA-1. The three remaining borings, GA-14, GA-15, and GA-16, will be located on the west side of Adeline Street, south of previous borings borings GA-2 and GA-3. Each borehole will be logged by a qualified Gribi Associates field scientist in accordance with the Unified Soil Classification System.

At least one soil sample and one grab groundwater sample will be collected from each soil boring. Soil samples will be collected at approximately four-foot depth intervals, or when obviously contaminated soils are encountered. Grab groundwater samples will be collected after placing temporary well casing in the borings. Soil and grab groundwater samples will be collected in accordance with standard sampling protocols.

Laboratory Analysis

Approximately ten soil samples and five grab groundwater samples will be analyzed for the following parameters:

USEPA 8260B Halogenated Volatile Organic Compounds (HVOCs)

All samples will be analyzed by a state-certified laboratory with standard turn around on laboratory results.

Data Evaluation and Reporting

Upon completion of the previously described activities, a summary report will be prepared for submittal to ACDEH. The report will describe and document the results of the field investigations.

PROJECT SCHEDULE

Subject to your authorization, Gribi Associates is prepared to begin project activities immediately, with completion of proposed field activities within approximately four weeks, and completion of the summary report within approximately six to eight weeks.

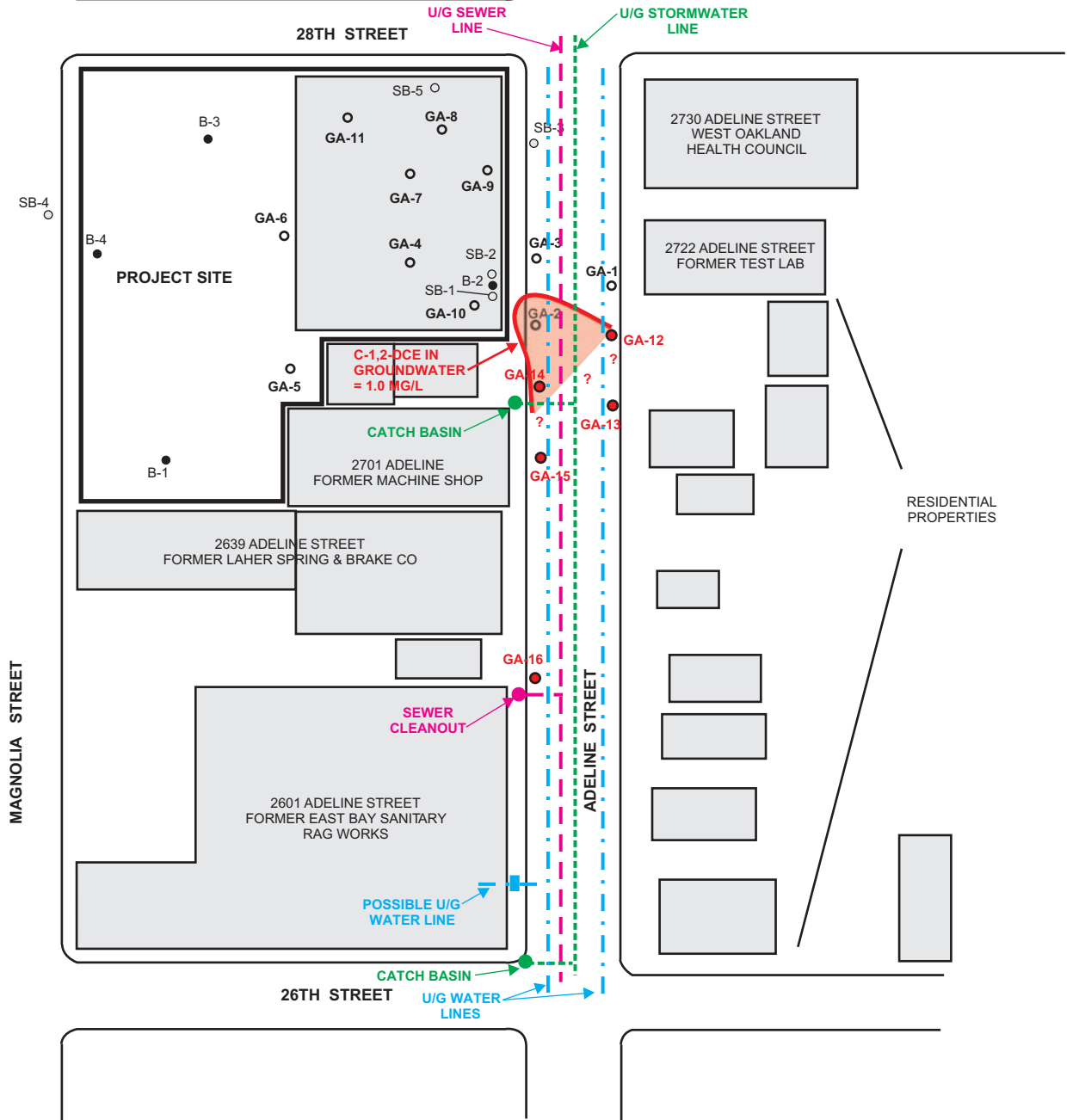
