This e-mail is a follow-up to my voicemail from earlier today regarding the above referenced site. We are requesting a month extension on the report due October 8 due to numerous factors, primarily the following:

- Took us awhile to get authorization to perform the work
- Took us awhile to identify and contact appropriate representatives from Safety Kleen to access their wells – Have now contacted TriHydro, their consultant, and access is being worked out
- We want to perform the sampling simultaneously so we can also use the data for gradient calculations over larger distance.
