Cambria Environmental Technology, Inc. (Cambria) is submitting the following area well survey on behalf of Chevron Products Company (Chevron). The survey was performed in response to your request in a letter dated June 10, 2004.

The location of the former Standard Oil (Chevron) facility is a triangular-shaped lot at the intersection of Portola Avenue and First Street in Livermore, California (Figure 1). Cambria used information obtained from GeoMatrix consultants to complete this well survey. GeoMatrix contacted the California Department of Water Resources (DWR) and Alameda County Zone 7 Water District and requested they review their records for wells within a ¾-mile radius of 3800 First Street, Livermore, California.

The DWR identified two well locations within a one-quarter mile radius of the site (Figure 1). The two nearest well locations are of a cluster of three monitoring wells located approximately 435 feet to the northeast, and a municipal well located approximately 1,200 feet south of the site. Five wells were identified between one-quarter and one-half miles from the site. Four of these wells are identified as monitoring wells and one is a well of unknown use. The well of unknown use is located approximately 2,300 feet east of the site, and is likely used for industrial purposes, as it is owned by Coast Mfg. & Supply Co. Seven additional wells were identified beyond a one-half mile radius of the site. Two of these are municipal wells, one is a domestic well, one is unknown, and three are monitoring wells. Table 1 presents details of all known wells in the area.

According to the USGS Livermore 7.5 Quadrangle map, no significant surface water exists within 2,000 feet of the site. The Zone 7 Water Agency Groundwater Contour Map for Fall 1996 indicates that the regional groundwater flow direction within the Livermore Valley is towards the northwest. Groundwater in the vicinity of the site has also been indicated to flow towards the southwest, according to a site investigation report conducted by Tom Edwards & Associates in 1993. Based on the above information, no known drinking-water wells or surface waters are likely to be impacted by hydrocarbons from the site.



Well Survey Map (1/2- and 1/4- Mile Radii)


