Dear Mr. Roberts, Ms. King, and Paul Hersh LLC,

This is in followup to recent phone conversations and electronic messages. In regards to the subject site, the City of Emeryville's has verbally requested a 6-week delay in the meeting requested by Alameda County Environmental Health (ACEH) in our December 31, 2012 directive letter for the referenced site. The subject site has been redeveloped and requisite documentation of site actions or cleanup has not been provided. As a result of case review associated with another related case at the property under the Low-Threat Closure Policy, ACEH requested the meeting with all responsible parties, including the City of Emeryville; however, as noted, the City needs to seek funds to hire a consultant and that this process will take approximately 4 to 6 weeks. The City also has stated that additional time will be required in order to contract with an appropriate environmental specialist once funds are secured internally. ACEH is in agreement with the request and in order to keep the case moving and facilitate case closure, ACEH has extended the dates, as noted below.

- **Sixty Days After SCM and Data Gap Work Plan Approval** – Site Investigation Report  
File to be named: RO2615\_SWI\_R\_yyyy-mm-dd

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
