Looks like I have a permit number for all three wells MW-1 to MW-3 for this site. It is permit 98WR454. It states that it was destroyed on Oct 27, 1998 to Nov 30, 1998.

Zone 7 Water Agency at that time did the permit and inspection. When the Public works agency took over in 1995, the data for the records was transferred over, but the actual hard copy was not. No Well Completion Report was also filed for the destruction of these wells. From the letter and the information I have, I would say that the wells were indeed destroyed at that time.

Would this be sufficient for ACPW to determine if three wells have been destroyed at the Grove Valve and Regulator Co (6521 or 6529 Hollis St, Emeryville)? Or would the wells still be considered potentially lost, until someone checked the grounds of the facility?

I don't recall when ACPW received well permitting from Zone 7, but this may predate that event and could some records be poor (?) That's a question, not a statement.
