Alameda County Environmental Health (ACEH) staff has reviewed the Spills, Leaks, Investigations, and Cleanups (SLIC) case file for the above referenced site including the recently submitted information contained in an electronic mail message dated June 15, 2010. The June 15, 2010 message, which was prepared by Mr. Ed Conti of AMEC Geomatrix on behalf of Pacific Shops, Inc., included three figures: Figure 1 is a site plan; Figure 2 presents pre-excavation soil analytical results; and Figure 3 presents post-excavation analytical results. We thank you for compiling the analytical data and preparing the requested figures.

Based on the compilation of soil analytical data, the electronic mail message contains a conclusion that only a few post soil cleanup (excavation and high efficiency vacuuming) samples have concentrations that exceed human health screening criteria. Cyanide was detected in post-cleanup soil sample 2502 at a concentration of 2,300 milligrams per kilogram (mg/kg), which exceeds the human health screening level of 34 mg/kg. However, the concentrations of cyanide in surrounding post-cleanup soil samples were significantly lower than the result for sample 2502. Nine additional soil samples contained metals at concentrations that exceed screening criteria. However, the locations and depths of these soil samples are unknown. The June 15, 2010 electronic message suggests it is possible that soils at the locations of the nine additional samples were removed as part of the site cleanup in April and May 1990.

No further investigation or remediation is requested for metals and cyanide in soils at this time. The need for a deed restriction will be reviewed at the time of case closure pending results from the investigation of volatile organic compounds (VOCs) discussed below.

The June 15, 2010 electronic message summarizes information from four soil samples that were analyzed for VOCs and requests that indoor air sampling not be required. VOCs were not detected at concentrations above the reporting limits in any of the four soil samples. We have reviewed the VOC results for these four locations and conclude that these data are not sufficient by themselves to conclude that VOCs are not present at the site. Two of the four soil samples (2500 and 2501) were collected at the surface and a third soil sample (2499) was collected on top of asphalt. Given the effects of volatilization at the surface, these three soil samples cannot be considered to be of sufficient quality to accurately represent subsurface conditions for VOCs. The fourth soil sample (2502) was collected at a depth of 4 feet bgs. Given the limited volume of soil represented in this sample, this single result is not sufficient to conclude that VOCs are not present at the site. Therefore, we request that you submit a Work Plan to conduct soil vapor sampling or other appropriate sampling to assess whether VOCs are currently present within the area of previous discharges and if present, whether VOCs potentially could pose a risk for vapor intrusion to indoor air for the existing building.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (http://www.swrcb.ca.gov/ust/electronic_submittal/report_rgmts.shtml.

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF)
 with no password protection. (Please do not submit reports as attachments to electronic mail.)
- It is **preferable** that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- Do not password protect the document. Once indexed and inserted into the correct electronic case file, the
 document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#_Report Name_Year-Month-Date (e.g., RO#5555_WorkPlan_2005-06-14)
