Dear Ms. ZumBrunnen and Mary & Michael Dudum:

Alameda County Environmental Health (ACEH) staff has reviewed the fuel leak case file for the above-referenced site including the document entitled, "Additional Subsurface Investigation Report, 2512 107th Avenue, Oakland, California," dated May 1, 2013 (Report). The Report, which was prepared on behalf of Michael and Mary Dudum by Allterra Environmental, Inc., presents results from three soil borings advanced to collect soil and groundwater samples within the area of and downgradient from five former hydraulic hoists and reservoirs inside the on-site building.

Total Petroleum Hydrocarbons as motor oil were detected in soil and groundwater samples at concentrations below Environmental Screening Levels (San Francisco Bay Regional Water Quality Control Board February 2013). The volatile organic compounds tetrachloroethene and cis-1,2-dichloroethene were detected in groundwater at concentrations up to 2.8 and 6.4 micrograms per liter, respectively, which are also below Environmental Screening Levels (San Francisco Bay Regional Water Quality Control Board February 2013).

Based on these results, the Report prepared by Allterra, recommends no further investigation and that the site qualifies for case closure. ACEH will evaluate the case for closure. No further work is requested at this time pending completion of the case closure review process,
