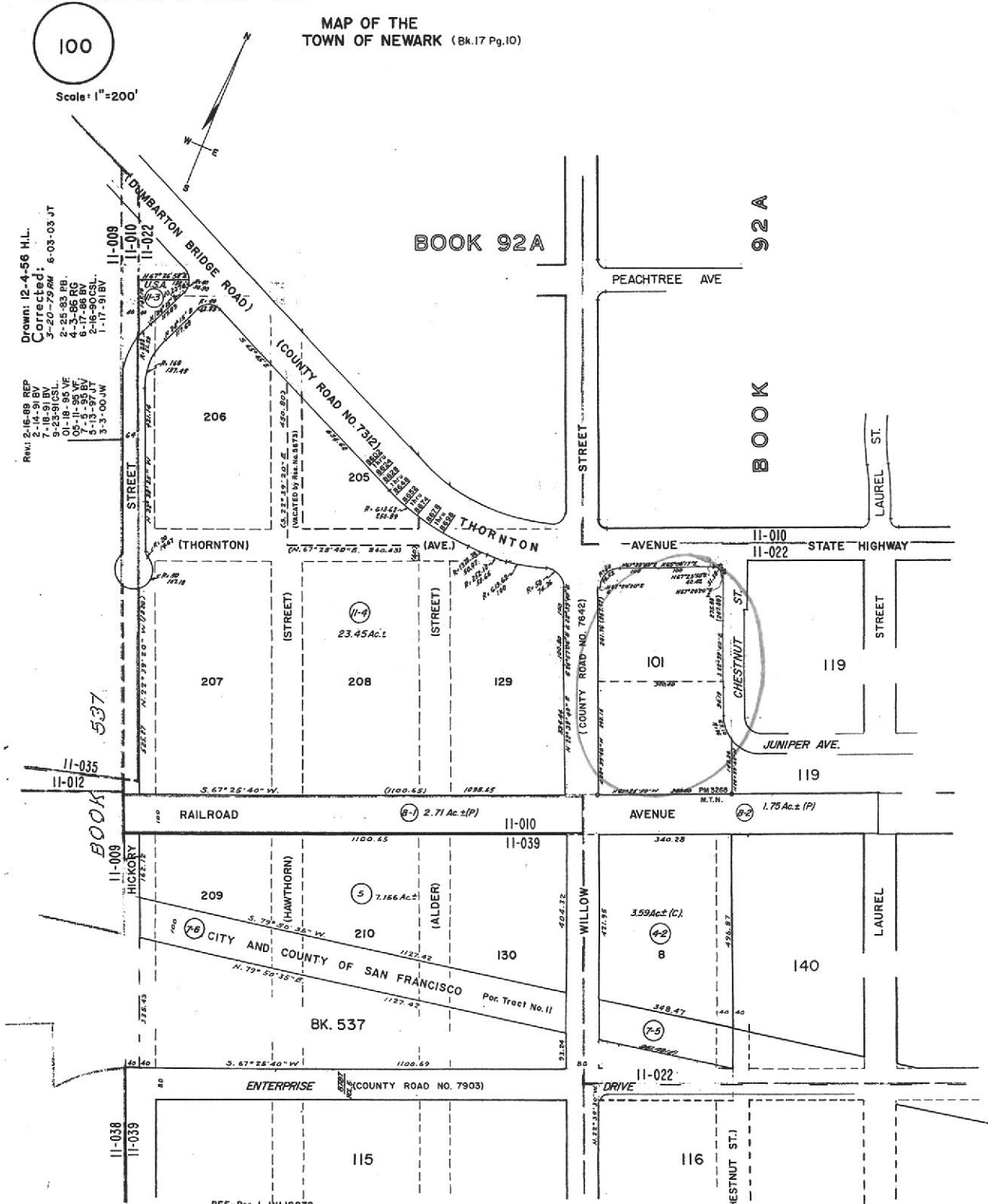
MAP OF THE TOWN OF NEWARK (Bk. 17 Pg. 10)

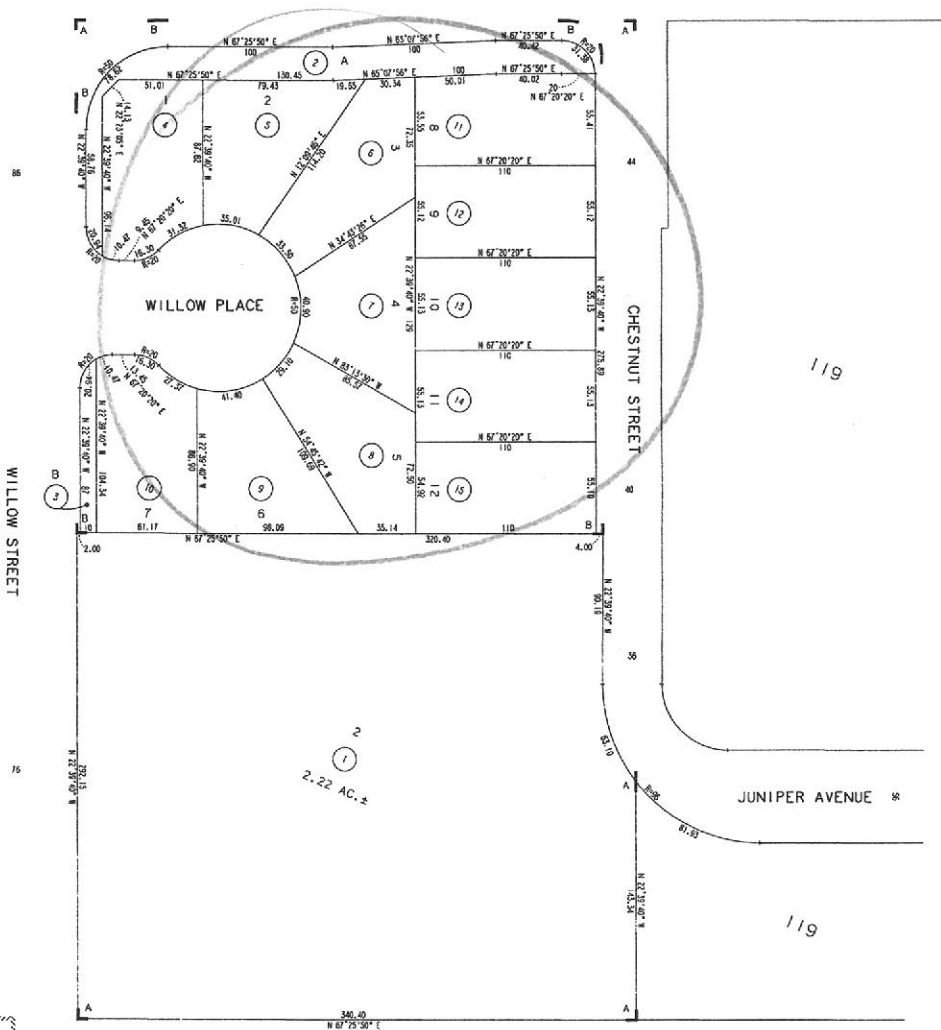
