Pacific Gas and Electric Company (PG&E) is in receipt of your July 24, 2009 Notice to Comply (NTC) letter for Geotracker upload for Fuel Leak Case RO0002751, GeoTracker Global ID T06019795861, 5051 Coliseum Way, Oakland, CA, 94601 (attached). PG&E currently is overseeing activities at a nearby site with a different GeoTracker number (which is in full GeoTracker compliance); however, PG&E's site is unrelated to the 5051 Coliseum Way site for which the NTC references. We

understand that you will be out of the office until August 17th, therefore, to resolve this item, we are requesting a 11-day extension (to August 21) for the following reasons:

- The current project manager for the nearby PG&E site is Anne Conner (phone number: 925-415-6381). Previously, Anne was working with Jerry Wickham on the nearby site (4930 Coliseum Way). The NTC was not addressed to Anne and as a result, was received by her only today (August 10th).
- As noted above, you are out of the office until August 17th. In your absence, both Anne Conner and I separately communicated this item to Donna Drogos; in a conversation with Anne, Donna suggested we send an e-mail to you to request an extension to formally respond to the NTC.
- We have done an internet search of the address cited in the NTC and note that the Water Board recorded a Covenant and Environmental Restriction in 2002 for this property, which is documented to be owned by DODG Corporation, not PG&E.

From Anne's conversation with Donna, we understand County will not issue a Notice of Violation to PG&E as we work to resolve this item. We greatly appreciate this consideration and look forward to resolving this item upon your return from vacation.
