Hi Roger,

A similar requirement to investigate the contamination was required of previous property owners without a response; however, the agreement is a recent change (within last year). There have not been any actions at the site which is the big problem at the site, and why it will be appropriate to refer the case to the other agency I've mentioned if actions are not continued. Health risks associated with a release of PCE can be significant, and continued delays are not acceptable. The full name of the agency is the San Francisco Bay Regional Water Quality Control Board (or RWQCB), and they are part (the local branch) of the State Agency that oversees contaminate site investigations. That agency is in Sacramento, and is the State Water Resource Control Board or (SWRCB). The RWQCB is located at 1515 Clay Street, Suite 1400, in Oakland.

I've sent an electronic copy of the agreement forms to you and Mr. Reynoso. He or his former wife or them together would need to sign the one page form to start an agreement process. We would fill out the full agreement paperwork after that for his, or her, or their signatures, and request funding. The standard initial funds request is \$6,000.
