Thanks for the email. The NOV was issued for two reasons:

- 1) I do not believe that ACDEH had been advised that an assessment per the directive letter was actually occurring. I do recall it was discussed as a potential, but I do not believe there was a subsequent communication. I believe the submittal you mention would be a response, and we can assess the need for a meeting upon review of the submittal.
- 2) Valentino Reynoso has been in contact with ACDEH this and last week in regards to a deadline for the judge in his divorce proceedings. This is the only deadline that ACDEH can provide at this time, and due to the lack of further communication it was unclear to ACDEH that progress was underway. It is great to hear that it is!

I received the Alameda County Environmental Health Department (ACEHD) directive letter this morning for the Sunshine Cleaners site. It was my understanding, in our last phone correspondence when the initial meeting was cancelled, that if the responsible parties (RPs) were willing to proceed with the assessment and requirements within the directive letters, that a meeting could be forgone. It is AGE's intention, with final cost approvals from the clients, to proceed with the required actions in

the directive letters. AGE is finalizing cost estimates for the RPs and anticipates providing ACEHD a schedule to begin completing the tasks in the directive letters by 14 December 2018.
