Hi Paul,

Yes, in a sense he did. I've copied Tom as I had forgotten to update both of you on the site.

I eventually realized that the reports were getting rejected due to a lack a registered signature and stamp, a requirement here. Once I realized that Tom was simply submitting reports conducted by others (as we unknowingly [I think] requested) I contacted that consultant directly and got revised signed and stamped reports. This allowed us to take the next step with the project. However, rather than close the case what we have done is to transfer the case to the SF RWQCB. The RWQCB opened a case (Pixar Animation Studios (Geotracker # T10000000727)) that encompasses the former Pepsi-Cola properties and the Del Monte Plant 35 (also transferred to the RWQCB) as Tom's letter to us said. This is probably not exactly what you had wished; however, since there is an on-going case (as opposed to a closed case) associated with the old releases under the Pixar name, we judged it appropriate to transfer both cases. We thought it more appropriate for Mark Johnson, the case worker at the RWQCB, to make the judgment if the old cases should be closed while just keeping the Pixar case going.

Hope this helps. It's not exactly as you wanted, but it takes the next step forward, and opens the possibility of the RWQCB closing the older cases associated with the newer one. That might be my guesstimate, but I can't exactly prejudge Mark's thinking; there may be a reason to keep them open form his perspective. Let me know if you have questions. Best.
