Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Existence of Unauthorized Release

On February 24, 1993, one 1,000-gallon and one 300-gallon gasoline underground storage tanks were removed from the site. Following UST removal activities, soil and groundwater sampling was conducted at the site. Groundwater impact was detected from use of gasoline fuel indicating an unauthorized release had occurred.

Responsible Party Identification

Robert A. Brooks, now Robert A. Brooks Trust, owned the subject property from circa 1971 and is the current property owner. Robert A. Brooks Trust is a responsible party because it owned the USTs (definition 1), operated the USTs for storage of hazardous substances (definition 2), owned the property where an unauthorized release of a hazardous substance from an underground storage tank has occurred (definition 3), and had control over the USTs at the time of or following an unauthorized release of a hazardous substance (definition 4).
