At a surface level, your proposed plan seems reasonable. However, please prepare a work plan with details about the proposed work, accompanied by your initial SCM to justify the proposed batch groundwater extraction event. This results of this work can then be used to update the SCM. I will include the request for a interim remedial action work plan in the forthcoming directive letter providing review comments on recently submitted reports and requests for a project schedule, preferential pathway study, initial SCM, groundwater monitoring, and data gap investigation activities , as we discussed yesterday.

Good morning Dilan,

Thank you again for meeting with Steve Carter and I yesterday. After our meeting, Steve and I sat down and reviewed our notes and discussed the upcoming groundwater sampling event for 3Q 2012. We'd like to propose that in addition to the wells being sampled (as usual), we'd like to follow the sampling event with a batch groundwater extraction event (using a vacuum truck) on the 5 onsite wells (DW-1 through DW-5) that exhibited the surfactant and then collect post-extraction samples from these wells for comparison purposes.

We'd like to include this data in the Site Conceptual Model; with your concurrence, we will plan and schedule this work during August.
