Hi Steven,

Thank you for your response.

Our client group (Mr. Roessler and others cc'd herein) have indicated an interest to meet with you together with us so that we can present to you the results of the interim remedial action and so that we can discuss the next course of action at the site together. If you recall, the group had asked for a meeting with you prior to the pilot testing, but you suggested that the meeting take place after the remediation had been initiated.

Indeed, the discontinuation of the SVE system was based on declining concentrations observed following 2 months of system operation, a decline in the system mass removal rate during this period, and the results of post-remediation sampling (i.e., rebound sampling after approximately one month of system shutdown). Attached is a copy of my October 13, 2009 email to you which provided some of the results of the interim remediation after 2 months of operation and indicated our plans to terminate the SVE operations and perform post-remediation sampling one month after system shutdown. To the extent that the post-remediation sampling indicated little to no rebound that that a significant reduction in PCE levels in the site wells has been accomplished, we would like to meet with you to present these results and discuss the next steps.

Based on the above, please let us know if you are amenable to a meeting and if so, what dates may be favorable to you.
