> As previously stated in an e-mail to Mr. Roessler, ACEH is currently awaiting direction from DTSC's public participation group as they consider the public participation process an important and crucial element of the site cleanup process.
>
> ACEH would like to take this opportunity to address any misconceptions you may have and to clarify past directives. You are correct that ACEH stated that interim remedial action may be implemented concurrently with public notification. However, it was based on the expectation that public notification would be complete (i.e. fact sheets distributed to all parties within the vicinity of the cleaners). Please note that ACEH was not aware that another preschool is located across the street until the Montessori School had brought that to our attention. ACEH understands that the Responsible Parties have made efforts to notify the parents and guardians of children who are currently enrolled at the Montessori School. However, that fact remains that those parents and guardians of children who are currently enrolled at the Montessori School have not been notified of the status of the current remediation at Crow Canyon Cleaners, including the pending soil vapor extraction remediation system operation, as the previous Fact Sheet was distributed a few years ago.
>
> ACEH relies on the Responsible Parties and their consultant to complete tasks that have been approved. It now appears that public notification has not been completed and subsequent delays appear to be attributed to the incomplete public notification, rather than any ACEH action or directive.
>
> ACEH will notify the Responsible Parties as soon as we receive a response from to our inquiry from the DTSC.
