Dear Mr. Carmel:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced site including the recently submitted document entitled, "Soil and Groundwater Investigation Work Plan," dated August 28, 2009, which was prepared by Broadbent and Associates, Inc. (BAI) for the subject site. BAI proposes to install three additional groundwater monitoring wells with MW-5 located adjacent to MW-1 to "determine if anomalous water levels observed in MW-1 are localized perched water bearing zone" and MW-6 and MW-7 to determine the extent of groundwater contamination.

Although ACEH generally concurs with the a portion of the proposed scope of work, ACEH has concerns regarding the proposed off-site monitoring well locations and requests that you address the following technical comments described below and send us the Work Plan Addendum by the date requested below.

### **TECHNICAL COMMENTS**

1. Expedited Site Assessment – BAI proposes to install one groundwater water monitoring well (MW-5) in the vicinity of existing groundwater monitoring well MW-1 and two additional wells (MW-6 and MW-7) to the northwest of the station on the neighboring property to further define the extent of petroleum hydrocarbons in groundwater. It appears that the locations for monitoring wells MW-6 and MW-7 were selected based on groundwater flow direction calculated on March 20, 2009 to be in a north to northwesterly direction. However, the groundwater flow direction calculated on November 9, 2009 is to a south southwesterly direction. Therefore, ACEH is concerned that even with the installation of the two proposed monitoring wells (MW-6 and MW-7) the extent of groundwater impact may not be adequately characterized. To that end, please justify that the proposed monitoring well locations will adequately characterize the groundwater contaminant plume off-site or propose an alternate scope of work. ACEH recommends that direct push borings are proposed off-site to adequately characterize the site prior to installing permanent groundwater monitoring points. Please submit a work plan addendum, due by the date specified below.

- 2. Regional Geologic and Hydrogeologic Setting BAI states that anomalous groundwater elevations observed in groundwater monitoring well MW-1 may be a results of perched groundwater. In addition to boring logs and well completion details, please prepare and include cross-sections in the soil and groundwater investigation report.
- 3. Groundwater Sampling Frequency Currently, semi-annual groundwater sampling is being conducted at the site. Since new groundwater monitoring well(s) will be installed, a revised monitoring frequency evaluation appears warranted. Therefore, please submit a groundwater monitoring plan for review. This may include a combination of quarterly, semi-annually, or annually sampled groundwater monitoring wells. Please include the proposal in the soil and groundwater investigation report due by the date specified below.

### NOTIFICATION OF FIELDWORK ACTIVITIES

Please schedule and complete the fieldwork activities by the date specified below and provide ACEH with at least three (3) business days notification prior to conducting the fieldwork.

### **TECHNICAL REPORT REQUEST**

Please submit technical reports to ACEH (Attention: Paresh Khatri), according to the following schedule:

- April 12, 2010 Soil and Water Investigation Work Plan Addendum
- April 5 or 30, 2010 Semi-annual Monitoring Report (1<sup>st</sup> Quarter 2010)

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

### **ELECTRONIC SUBMITTAL OF REPORTS**

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and other data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is

required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (<a href="http://www.swrcb.ca.gov/ust/electronic\_submittal/report\_rqmts.shtml">http://www.swrcb.ca.gov/ust/electronic\_submittal/report\_rqmts.shtml</a>.

### PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

### PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

### UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

## **AGENCY OVERSIGHT**

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

**SUBJECT:** Electronic Report Upload (ftp) Instructions

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

### **REQUIREMENTS**

- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF)
   with no password protection. (Please do not submit reports as attachments to electronic mail.)
- It is preferable that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- Do not password protect the document. Once indexed and inserted into the correct electronic case file, the
  document will be secured in compliance with the County's current security standards and a password.
   Documents with password protection will not be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

RO#\_Report Name\_Year-Month-Date (e.g., RO#5555\_WorkPlan\_2005-06-14)

A separate copy of the tables in the document should be submitted by e-mail to your Caseworker in Excel format.
 These are for use by assigned Caseworker only.
