This letter presents an addendum to the Site Conceptual Model for the former Video Maniacs Parcel located at 2305 Central Ave. in Alameda, California (the Site), submitted to you on August 4, 2006. This addendum has been prepared as requested in your February 13, 2007 email to Josh Otis of Northgate. The addendum presents the results of a well survey performed within 2,000 feet of the subject Site, based on data provided by the California Department of Water Resources (DWR) and the Alameda County Department of Public Works (ACDPW).




FIGURE 1 Site Location Map

In summary, well records provided by the DWR and the ACDPW indicate the presence of 21 monitoring wells and four shallow (28.5 feet deep or less) irrigation wells within 2,000 feet of the subject Site. Agency data for wells within 2,000 feet of the subject Site are summarized in the attached Table 1, and well locations are presented graphically on Figures 1 and 2. The monitoring wells range in depth from 11.5 feet to 30 feet, and the irrigation wells range in depth from 19 feet to 28.5 feet. None of the irrigation wells are located within 1,000 feet of the subject Site. According to previous reports, the groundwater flow direction in the subject Site vicinity is predominantly toward the east. Based on our review, the only wells that are located downgradient from the subject Site are monitoring wells on the Goodman Property, at 2501 Santa Clara St, a distance of about 1,100 feet from the subject Site.

Based on our review, none of the identified wells are likely to be impacted by groundwater conditions at the subject Site given the use, distance, and topographic location of the wells relative to the Site.


