I am the dealer operating the Shell Station at 1801 Santa Rita Rd., Pleasanton, CA 94566. I have an interest in seeing to the environmental health of the site besides Shell Oil. I am looking into the environmental status of LUST incident reported back in year 2002 in case #T0600144714. I studied the report extensively as recorded in Geotracker but did not find a reference to what was the root cause of the release or how it was uncovered. Was this a voluntarily effort by Shell to install the monitoring wells which led to the discovery of the release or this site had a history release prior to 2002 that resulted in the active assessment? Would the site assessment requirement be an on going activity for the remaining life of the site as long as it operates as a service station?

I would appreciate very much if you could provide us with additional history of the release. If you do not have such information, I would appreciate your direction to the source.
