Dilan:

I hope that this finds you well.

This follows Piedmont Station's submission on July 22, 2014 of the site history and REC matrix and P & D Environmental's work plan for the post demolition subsurface and soil testing.

The work to remove the exterior paint on the building is well along and has proceeded in an orderly and safe fashion. We expect that work to be finished within the next 7-10 business days.

Demolition of the building will then begin, with estimated completion the first week of October 2014.

Then P & D will perform its work per the work plan it submitted as soon as practicable after demolition is complete. The work plan has identified points where P & D will take test borings within the footprint of the former building and where it will test soil after light grading and stockpiling for lead. Paul King has committed to completing this work, getting lab results, and preparing his report in expedited fashion. Based on what I understand from our previous subsurface investigations and the residual lead in the soil after PG&E's previous soil removal, I have a high level of confidence that the site will meet residential ESLs.

The urgency here for us is that County site closure is a condition precedent to the issuance of a building permit by the city of Piedmont. The permit otherwise will be ready to issue when demolition is completed. Our general contractor will be waiting in the wings to get started on actual construction. And all of this is in the context this is in the context of our company as borrower on a construction loan of almost \$6 million dollars.

I hope that you can understand that there really is no other way to sequence this project, and can appreciate our need for a predictable process with identified milestones and tasks in getting the site closed. Now that we have a much clearer picture of the timeframe of completion of demolition, Paul King and I would like to meet with you with a view to mapping out the closure process and timing of the process.

As always, I appreciate your attention to this matter and I look forward to hearing from you.
