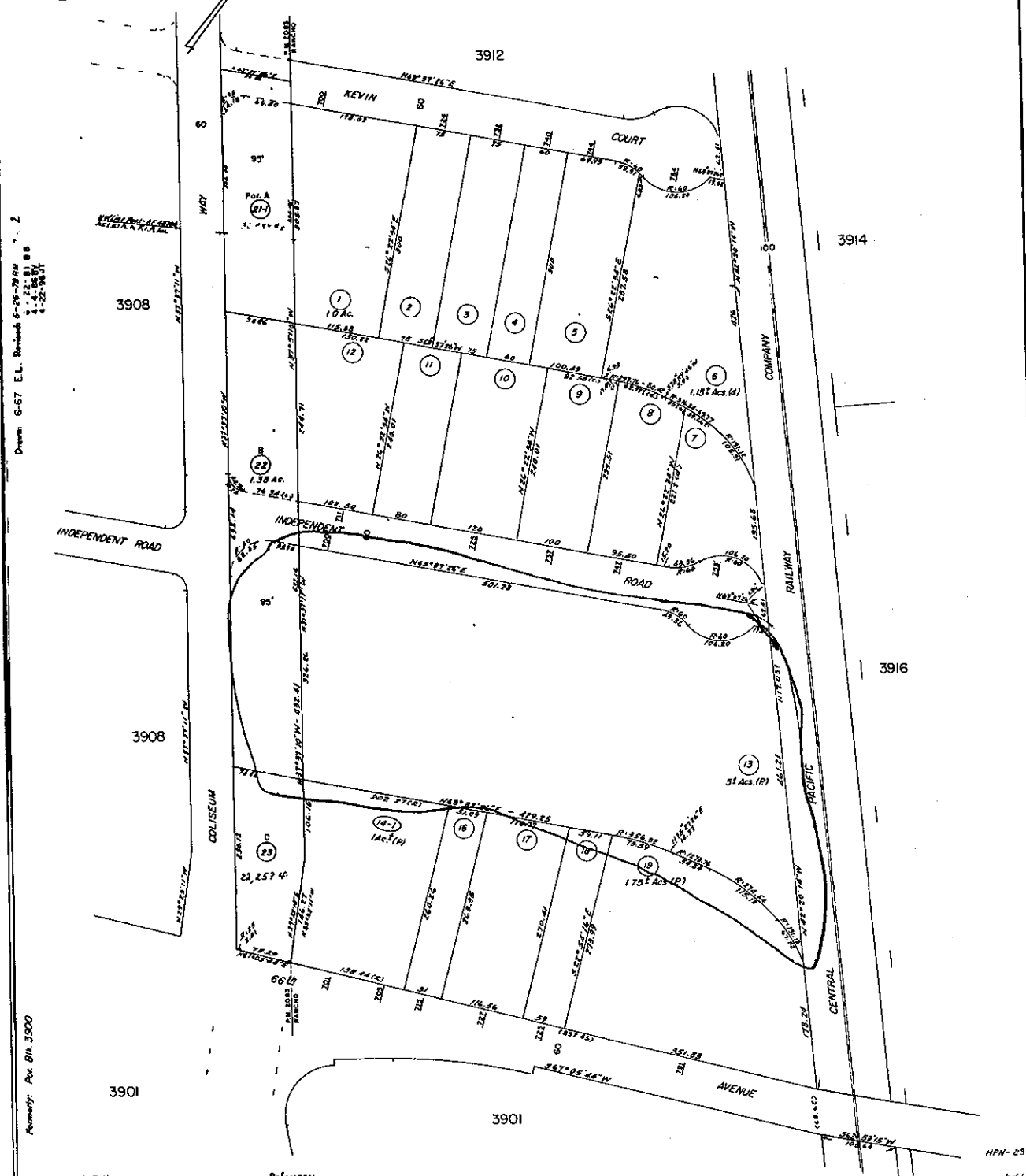
# ASSESSOR'S MAP 41
