Per our conversation, I am writing to provide you with the status of the work proposed for Mills Square Park in the Work Plan for Lead Delineation in Soil dated June 1, 2015 (Work Plan). The Work Plan noted that work would begin following "acceptance of conditions of work by the City." In an effort to implement the work promptly, CEMC simultaneously scheduled the soil sampling (to commence June 22, 2015) and attempted to reach agreement with the City on the conditions of this work. To date we have been unable to schedule a meeting with the City to discuss a path forward. We therefore have postponed the work, pending resolution of the outstanding issues with the City.

We will provide you with an update as soon as the work is re-scheduled.
