Jerry-

As discussed during our January 9, 2013 telephone call regarding ACEH's November 26, 2012 letter, a soil management plan will be submitted in lieu of a work plan for interim removal action. The soil management plan will contain provisions for mitigating surface exposure to soils containing lead greater than 80 mg/kg (such as removing the top 1-foot of soil where accessible or covering with fabric and bark where removal is not feasible).

Due to ongoing coordination/meetings with the City of Livermore and the pending renovations to the park (in the initial stages at this point in time), CRA requests a 3 month extension on the submittal of the soil management plan. This will allow for coordination and review/approval of the City prior to submittal of the soil management plan. Upon ACEH approval, the new due date for submittal of the soil management plan will be April 30, 2013.
