Alameda County Environmental Health (ACEH) has received the report entitled, "Phase II Subsurface Soil and Groundwater Sampling Site Assessment," dated May 11, 2007, which concludes that further site investigation or cleanup is not warranted for the site. ACEH staff is in the process of reviewing the above referenced case for possible closure. However, we note that although documents have been submitted in electronic format to the ACEH ftp site, no documents have been submitted to the State Water Resources Control Board (SWRCB) Geotracker website. Submittal of data and reports in electronic format to the SWRCB Geotracker website is a mandatory requirement.

Pursuant to CCR Sections 2729 and 2729.1, beginning September 1, 2001, all analytical data, including monitoring well samples, submitted in a report to a regulatory agency as part of the LUFT program, must be transmitted electronically to the SWRCB Geotracker website via the internet. Beginning July 1, 2005, electronic submittal of a complete copy of all reports is required in Geotracker (in PDF format). Please upload all analytical data (collected on or after September 1, 2001) and a copy, in PDF format, of all reports prepared after July 1, 2005.
