## Good morning Donna.

I saw your message to Joseph and thought I could put in. We have to have all OSCA funds encumbered, both for assessment and for cleanup by Dec. 2007. ## Donna and Steven,

In order to have OSCA assessment grant funds <u>encumbered</u> Pat needs: 1) approval of the statement of work (SOW) in the pre-grant acceptance documents, and 2) a directive letter from your department stating that additional characterization of the site is necessary. Once Pat has this information she can encumber the funds for the <u>assessment</u> grant and we can move forward (i.e., prepare workplan, get it approved, and start field work). Once the site has been fully characterized to your satisfaction, we can start to generate costs estimates for site cleanup and then encumber funding for the OSCA <u>cleanup</u> grant. The time-sensitive issue is completing the assessment of the site in time to develop costs for the OSCA cleanup grant and to encumber the cleanup funds.

Hopefully this clarifies things. I know the whole process can be somewhat confusing, especially when you have so much other things going on. I also understand that you and your staff have are quite busy and have a lot on your plates. However, OSCA funding provides an excellent opportunity to characterize and cleanup sites that would otherwise go unattended.
