Alameda County Environmental Health (ACEH) has performed a preliminary review of the investigative report dated January 10, 2014 entitled *Supplemental Site Closure Verification Sampling Report*, prepared by Impact Environmental Services for the subject site. ACEH is of the opinion the subject site may meet the general and media specific criteria of the State Water Resources Control Board's (SWRCBs) Low Threat Underground Storage Tank Case Closure Policy (LTCP). ACEH requests that you perform the following tasks in accordance with the following schedule identified below:

1. A review of the case file indicates that the SWRCB Geotracker database and/or the ACEH database is not complete, thus rendering the site to a non-compliant status pursuant to California Code of Regulations, Title 23, Division 3, Chapter 30, Articles 1 and 2, Sections 3890 to 3895. At present missing data and documents include, but may not be limited to:

- complete copies of reports, in pdf format, including the signed transmittal letter and professional certification (GEO_REPORT files);
- analytical data for soil, water and vapor samples collected for the purpose of subsurface investigation or remediation (EDF files);
- surveyed elevation measurements to the top of well casings (GEO_Z files);
- the latitude and longitude (GEO_XY files) of any permanent monitoring well for which data is reported in EDF format;
- depth-to-water information for permanent sampling points whenever the data is collected, even if the well is not sampled during the sampling event (GEO_WELL files);

- stand alone site maps displaying tank locations, streets bordering the facility, sampling locations for all soil, water and vapor samples, and groundwater monitoring report figures displaying groundwater flow direction and contaminant concentrations (GEO_MAP files);
- stand alone boring logs with depth to the screened interval and the length of screened interval for any permanent monitoring well installed (GEO_BORE files);
- 2. Upload a formal Request for Closure document to the SWRCB Geotracker and the ACEH websites.
