A Spills, Leaks. Investigations, and Cleanups (SLIC) case has been opened for your site in response to an unauthorized release in the area of a remote waste oil drain. In order for Alameda County Environmental Health (ACEH) to review SLIC cases, we require an oversight account to cover our costs. To set up your account, please send a check in the amount of \$6,000.00 payable to Alameda County Environmental Health. Please send your check to the attention of our Finance Department.

This initial deposit may or may not be sufficient to provide all necessary regulatory oversight. ACEH will deduct actual costs incurred based upon the hourly rate specified below. If these funds are insufficient, additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.

The deposit is authorized in Section 6.92.040L of the Alameda County Ordinance Code. Work on this project is being debited at the Ordinance specified rate, currently \$176.00 per hour.
