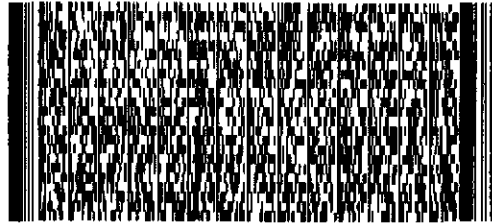

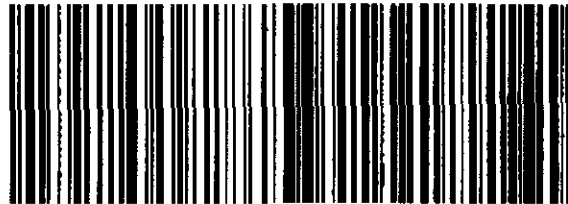

This is to acknowledge receipt of the letter from Ariu Levi dated September 13, 2007. The letter was received by fax today, September 14, 2007. Please note that this case should reflect Livermore Amador Valley Transit Authority (LAVTA), not MV Transportation.

Per our conversation today, I am requesting expedited handling of this case based on the fact that it was transferred to Alameda County Environmental Health per the enclosed letter from Livermore Pleasanton Fire Department dated December 21, 2006. It would seem that no action had been taken on this matter until I initiated a call to your office yesterday, September 13, 2007.

Also enclosed is a copy of the check #050016 that has been issued and sent via overnight delivery to your office for Monday arrival.

This letter is being sent to you via fax today, September 14, 2007 and the original is scheduled for delivery on Monday, September 17, 2007. As I mentioned in our conversation, delay of closure on this case is causing loss of revenue to the Authority, and I would appreciate a call from Donna Drogos or anyone else from your office having the authority to expedite this case. I trust that our quick action today bears witness to our willingness to cooperate and provide the County with whatever information is needed to close this case as quickly as possible.
