Thank you for speaking with me yesterday. As requested, I have contacted John Seng to set up access to the ftp site. I expect to have the Phase I ESA, the Phase I ESA addendum, and the UST Removal Confirmation Report uploaded later today.

As discussed, the Phase I ESA identified that the site was operated as a service station from the early 1930s to the early 1970s. The gasoline USTs were removed by James Carver in the early 1980s (see letter
