One other thought. In regards to the IRAP, I realized I did not see dust control measures or air monitoring discussed and they should be. The application of sufficient water to control dust is a good option to control dust, and perimeter dust monitoring and analysis for lead should work to document that the actions have not (presumably) impacted the local community.

Sami,

Thanks for the draft work plan for vapor sampling and the IRAP for the surface lead contamination (and the reminder call!). I've had a chance to review them and had several comments that should be incorporated before you finalize them. Alternatively ACEH can modify the work plan in our response letter so that they are incorporated into the scope of work.

IRAP - No modifications appear warranted. The overexcavation procedures appear appropriate.

Work Plan – The approach appears good; however, ACEH would or will request that the temporary vapor points be installed with hydrated bentonite (we've had problems with gasoline generator off-gases getting into a vapor sampling and seriously skewing the data), use of a shroud (bucket or upside down plastic storage container) to contain the tracer in a closed atmosphere, analytical sampling for the tracer gas in the shroud and vapor sample (to confirm that it is present in case it shows up in vapor sample; an acceptable ratio [vapor sample concentration vs. shroud concentration] is defined by DTSC guidelines), and the collection of atmospheric gases (oxygen, nitrogen, carbon dioxide) and methane to help determine if atmospheric gases have infiltrated the sample (short circuit) or if there is biodegradation underway in the subsurface.

Let me know if you have questions. Please request an extension to the submittal date for the final documents, so you are in good shape with state funding, and we'll have a submittal date targeted. Review should be even quicker now that I've seen these draft documents.
