Well, our excellent document production crew must have gotten ahead of themselves! (Oops; I guess there is always a first.) We apologize for the error.

Please could you put the paper copy back in the Fedex to us (2040 6101 7), so we can double check it and provide you with a final version. (Do you want it back? My understanding was that ACEH only accepted electronic versions.)

FYI, DTSC directed PG&E to install and monitor a well (since 1998) in the "sidewalk" on the south corner of the intersection of 2nd and MLK Blvd.; And Geomatrix is headed to obtain soil samples on the east corner of same intersection shortly (the property owner has been notified, however ACPWA didn't have any permits on file, although the mark out for USA has been done). We had just discovered this; I am working on getting permission to obtain grab gw samples from their boring locations when they are out there. (They are scoped with borings to 15' bgs and the gw is general @8' bgs.) We will keep you posted. If you have data on that well, soil boring log for MW-OAK-6, we would appreciate having it; Accessing information from DTSC or Envirostor is a challenge, and that installation report is not listed (would be circa 1998). Their current workplan is there, though.

Thanks for your attention to all of these details.
