Please find attached the summary figures and tables for the soil and groundwater just performed at the above referenced site. After a chance to review the data, we would appreciate your feedback about the direction to take at this site.

Here are our thoughts, based on several factors, including the following :

1. The source appears to be small and localized under the former fuel dispenser, based on the groundwater plume map;

2. The site is in an industrial area with extensive low level contamination present around the site;

3. Multiple utilities including gas, electric, telecom, sewer and storm sewer are located within the plume and make accessing all areas of the plume difficult;

4. A substantial new concrete pad has been poured inside the building over the former dispenser island,

minimizing vapor intrusion potential; and

5. The plume is now heading under PG&E Substation C, which already has a problem of equal or greater magnitude .

Clearwater believes this site poses minimal risk to the humans and the environment and would like it to be considered for closure. Clearwater would appreciate any guidance you could give at this site, would it be considered for closure or will more assessment and remediation be required.
