Alameda County Environmental Health (ACEH) staff has reviewed the Spills, Leaks, Investigations, and Cleanups (SLIC) case file for the above referenced site including the recently submitted correspondence dated July 9, 2007 which requests that a separate case be established for a portion of the Hanson Radium facility. Specifically, Hanson is requesting that the current ACEH case be limited to Parcel 1, which is an approximately 15-acre property including the former asphalt plant and an irregularly shaped area located south of the Kiewit property (see attached Figures 1 and 2 from the July 9, 2007 correspondence. A new case is to be established for the remainder of the Hanson Radium facility. Creation of a separate case was also discussed during a meeting held on June 22, 2007 in ACEH's offices. As indicated in the July 9, 2007 correspondence, Hanson Aggregates plans to retain the 15-acre Parcel 1 and transfer the remainder of the property to Legacy Partners.

We have no objection to this proposal. Therefore, regulatory oversight for the Hanson Radium facility will be conducted under two separate ACEH cases as follows:

next technical report requested for the Hanson Radum facility site is a Site Investigation Report to be submitted by October 26, 2007.



To set up your account, please send a check in the amount of \$6,000.00 payable to Alameda County Environmental Health. Please send your check to the attention of our Finance Department. Please write "SLIC" (the type of project), the site address, and **AR0320054** (accounts Receivable #) on your check.

This initial deposit may or may not be sufficient to provide all necessary regulatory oversight. ACEH will deduct actual costs incurred based upon the hourly rate specified below. If these funds are insufficient, additional deposit will be requested. Otherwise, any unused monies will be refunded to you or your designee.

The deposit is authorized in Section 6.92.040L of the Alameda County Ordinance Code. Work on this project is being debited at the Ordinance specified rate, currently \$166.00 per hour.
