I write on behalf of Legacy Pleasanton Land, LLC. Alameda County Environmental Health Services' October 14, 2009 technical comment letter responding to the Livermore-Pleasanton Fire Department's September 25, 2009 comment letter on the Facility Closure Plan dated June 19, 2009 for the former Hanson Aggregates Radum Facility located at 3000 Busch Road, Pleasanton, California, requested the submission of a Revised Closure Plan no later than December 1, 2009. By letter dated November 23, 2009, Lee Cover of Hanson Aggregates Northern California requested an extension of the submittal deadline to January 29, 2010. One of the reasons expressed by Mr. Cover for that extension was to allow Hanson and Legacy time to discuss closure responsibilities between themselves.

Please be advised that Legacy Pleasanton Land, LLC maintains its position that all responsibility for submission and implementation of the Revised Closure Plan rests with Hanson, the operator of the former Hanson Aggregates Radum Facility, and permittee under the Livermore-Pleasanton Fire Department's Fire Code and Uniform Program Consolidated Permit and Registration, permit No. 092800-33. The submittal and approval of a closure plan is one of the many obligations of Hanson under said permit. As such, Legacy Pleasanton Land, LLC will not be submitting any documentation to your agencies related to the Revised Closure Plan.
