Dear Tina Lau, Yutaka Fujimoto, and Melvin Kruschke:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above-referenced case. This case was initiated in response to visual evidence of soil contamination that was observed by inspectors from the Alameda County Certified Unified Program Agency (CUPA) Program in March 2007. Soil contamination was observed in two areas used for equipment maintenance and storage at the Hanson Aggregates Sunol facility (formerly Mission Valley Rock Company) located at 7999 Athenour Way in Sunol, CA. The two areas were apparently leased and occupied by Y's Equipment Rental and Big K Equipment Rental, respectively. On April 26, 2007, the case was transferred by the Alameda CUPA Program to the ACEH Spills, Leaks, Investigations, and Cleanups (SLIC) Program. ACEH requested funds for regulatory oversight and requested additional information for the two equipment maintenance and storage areas.

On July 24, 2007, ACEH received a report entitled, "Results of Subsurface Investigation in the Lessee Areas at the Hanson Sunol Former Mission Valley Rock Facility, 7999 Athenour Way, Sunol, California," dated July 20, 2007. This Report, which was prepared by LFR Environmental Management & Consulting Engineering, presents results from investigations conducted in the two lessee areas. The investigations were apparently conducted at the request of Hanson Aggregates as part of a due diligence investigation. Analytical results from twelve soil borings advanced during the due diligence investigation did not detect significant contamination. The July 20, 2007 LFR Report recommended that no additional soil and groundwater investigations and no remediation was needed.

Based on these investigation results and results from recent inspections by the ACEH CUPA, ACEH is considering closure of the SLIC case. If any additional environmental investigations to that presented in the report entitled, "Results of Subsurface Investigation in the Lessee Areas at the Hanson Sunol Former Mission Valley Rock Facility, 7999 Athenour Way, Sunol, California" dated July 20, 200 were conducted, please submit those results immediately. If no additional investigations have been completed, please provide verification by email or written correspondence that no additional information is available for these two areas.
