Thank you for reviewing the case. I just confirmed with the owner that he has two options for the site development:

His first choice is a multi-story building with ground floor for commercial and the second and the third floors for apartments.

If the residential at the second and the third floors is a problem, he can change his plan for all commercial development.

The ESL number for TPH gas and diesel in the lookup tables were developed based on freshwater aquatic life protection. For human health protection, the ESL document (Page 3 of Table I-2, Volume 2, February

2005 edition.

I'll also check the November 07 edition) listed 5,000 ug/L for TPH gas and 2,500 ug/L for TPH diesel based on nuisance and odor criteria for nondrinking water.

Because benzene was not detected in soil samples in the June 07 investigation and was detected in groundwater at only 2.3 ug/L, I think the site is suitable for mixed development, i.e. commercial at the ground floor and residential at the second and the third floors. For added protection, the owner is willing to put Liquid Boot down for vapor barrier.

Please let me know if there is anything I can do to assist your review.
