At the request of ExxonMobil Environmental Services (EMES), on behalf of Exxon Mobil Corporation, Cardno is notifying you of upcoming on-site sampling activities scheduled to begin Tuesday March 21, 2017. Cardno will be sampling the soil vapor wells SVS1 through SVS8 at the subject site. This event is expected to last one day and will require a support truck at the work location. 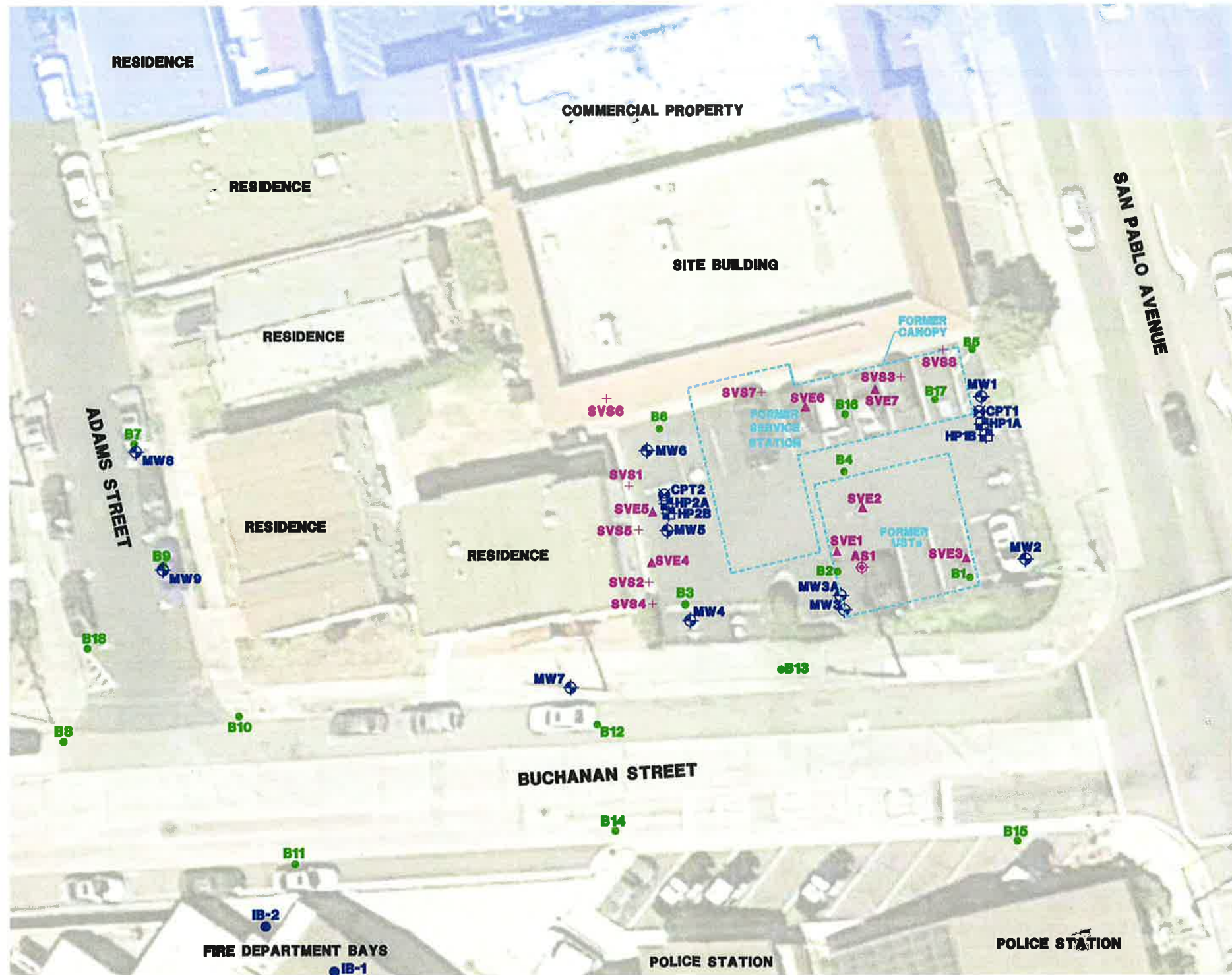

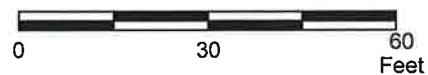
