

WORK PERFORMED THIS QUARTER (Second Quarter 2009):

- 1. Prepared and submitted *Addendum Work Plan for Soil & Ground-Water Investigation* (BAI 5/28/2009).
- 2. Began permitting and preliminary activities upon ACEH approval of work plan for soil and ground-water investigation (with addendum).
- 3. Cleared proposed boring locations of subsurface utility conflicts. Work performed on 28 June 2009 by Stratus Environmental, Inc. (Stratus).

DISCUSSION:

In a letter dated 29 January 2009, ACEH requested the preparation and submittal of an Underground Storage Tank (UST) Unauthorized Release Form and Soil and Ground-Water Investigation Work Plan. On 20 February 2009, BAI submitted the requested UST unauthorized release report form. On 30 March 2009, BAI submitted the requested soil and ground-water investigation work plan. On 16 April 2009, ACEH responded to the submitted work plan with technical comments and a request for a work plan addendum. On 28 May 2009, BAI submitted the requested addendum work plan. On 11 June 2009, ACEH approved the submitted work plan/addendum. Stratus was notified to implement the approved scope of work shortly after. Upon receipt of a certified field data package, BAI shall prepare and submit the requested Soil & Ground-Water Investigation Report. For reference, a site map from the submitted addendum work plan with proposed monitoring well locations is provided as Drawing 1.
