Thank you for taking the time to speak with me earlier this morning. As I said in our conversation, we discovered your Notice to Comply letter on Geotracker this morning after a prospective tenant asked us what the issue is with the open environmental case. We were perplexed because we thought any issue with the old gas station (your RO000371) had been resolved. We were not aware that a new case had been opened. Now, after our conversation, I understand that the new case involves the removal of the hydraulic lifts discovered near the old gas station site when the old Kragen store was demolished. Our understanding was that Conoco Phillips had completed removal and remediation. I see from your letter that part of the problem is that CP has not "claimed" the site on Geotracker by uploading their material. I also advised you that the owners of the property had not received your 7/24//09 letter because our address is incorrect on the letter.
