Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Responsible Party Identification

Existence of Unauthorized Release

In 1985, three fuel underground storage tanks (USTs) and one waste oil UST were removed from the site. Due to the former presence of USTs onsite, a subsurface investigation was performed at the subject property in 1994. The investigation included four soil borings advanced to a maximum depth of 20 feet below ground surface (bgs). Samples from three of the borings were analyzed for Total Petroleum Hydrocarbons (TPH) as gasoline, TPH as diesel, TPH as motor oil, and benzene, toluene, ethylbenzene, and xylenes (BTEX). Samples from the fourth boring were also analyzed for Total Oil & Grease (TOG). Concentrations up to 9 mg/kg TPH as motor oil were detected. MTBE was not analyzed for. USTs were again installed at the site in 2000. The data indicate that an unauthorized release has occurred at the site.

Responsible Party Identification

Texaco, Inc (and its successor Chevron) is a responsible party for the site because it owned or operated the USTs used for the storage of a hazardous substance (Definition 1), it owned or operated the USTs immediately before the discontinuation of its use (Definition 2), it owned the property where an unauthorized release has occurred, (Definition 3), and it had control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance (Definition 4).

Carl and Wanda Kuper purchased the property in March 1984. Carl and Wanda Kuper are responsible parties for the site because they owned the property where an unauthorized release has occurred, (Definition 3).

The Investment Enterprise Company purchased the property in June 1985. It is a responsible party for the site because they owned the property where an unauthorized release has occurred, (Definition 3).

The Independent Development Co, Inc. purchased the property in September 1985. It is a responsible parties for the site because they owned the property where an unauthorized release has occurred, (Definition 3).

Thomas D. Meek (c/o Dick Ballard, Inc.) purchased the property in November 1985. He is a responsible parties for the site because he owned the property where an unauthorized release has occurred, (Definition 3).

John C & Rose M McPhee, Trustees purchased the property in April 1994. They are responsible parties for the site because he owned the property where an unauthorized release has occurred, (Definition 3).

Kil N. Pang et.al. (Chief Auto Plaza LP) is a current property owner associated with the USTs since March 2003. Kil Pang (Chief Auto Plaza LP) is a responsible party for the site because they owned the property where an unauthorized release has occurred, (Definition 3).
