Mr. Wickham.

As stated in the email chain below, we had scheduled to install the two wells (MW-4 and MW-5) last week. Unfortunately, due to a misplaced utility locate by the City of Livermore, we were delayed by a few days and were only able to install MW-4. Two attempts made this week to install MW-5 were unsuccessful, due to utilities marked in the sidewalk on the west side of Vasco Road and unmarked utilities encountered at 6.5 feet bgs in Vasco Road near the western sidewalk. In order to move the well further east into Vasco Road, we will need to create a new traffic control plan and obtain a new encroachment permit. Before moving forward with the re-permitting of MW-5, Stantec would like to develop and sample MW-4 and include the groundwater analytical results in the forthcoming assessment report. We can sample the well next week, but we will need to delay the report to October 5. Please let me know if this is acceptable.
