Mr. Wickham, Good morning.

As you are aware, Stantec received the approval from you regarding our work plan for the well installation work at this site On October 27, 2010. In your work plan approval letter, you requested that the well installation report be submitted to your office by February 28, 2011. Since receipt of your approval, Stantec immediately moved forward with securing the required well installation permits from the Zone 7 Water Agency (Z7WA). The necessary permit application package was submitted to the Z7WA on November 8, 2010.

However, Stantec did not receive the executed well installation permits from the Z7WA until January 27, 2011. We immediately scheduled the next available dates with the drilling company for February 23, 2011 with the well development scheduled for March 1, 2011.
