Hi Jerry, hi Donna.

A quick and maybe easy Q for you. I have a client in the Jack London area who has a property that had a tank. They abandoned it in place a few years back, took the requisite samples, found the customary environmental signature, submitted the closure report to the FD.

A due diligence consultant for their bank did a City file review during refinancing examinations and found the report to not be there. I sent a copy to Mr. Griffin in October and have been trying to get in touch with him since to get an idea as to what he'd like to do next. But I hear his department is under-staffed and this is likely not high on the list of priorities so I'm guessing he has more important pressing matters.

I think the standard practice for sites such as these is for the FD to seek your counsel. My question for you is - has he contacted you? The site is at 645 Jefferson Street in Oakland. If he hasn't, is there an alternative course that we should take?
