Alameda County Department of Environmental Health (ACDEH) staff has reviewed the fuel leak case file for the above referenced site including the recently submitted documents entitled, "*Indoor Air Study* – *Report of Supplemental Findings*," dated April 13, 2016, and "*Site Assessment Complete Report and Case Closure Request*," dated May 20, 2016, which were prepared on your behalf by Blue Rock Environmental, Inc. The first report presents results from additional indoor air, outdoor air, and sub-slab vapor sampling that ACDEH had requested in a directive dated January 22, 2016. The second report presents results of additional soil and groundwater sampling to define the extent of the gasoline plume and recommends case closure under the Low Threat Closure Policy (LTCP).
