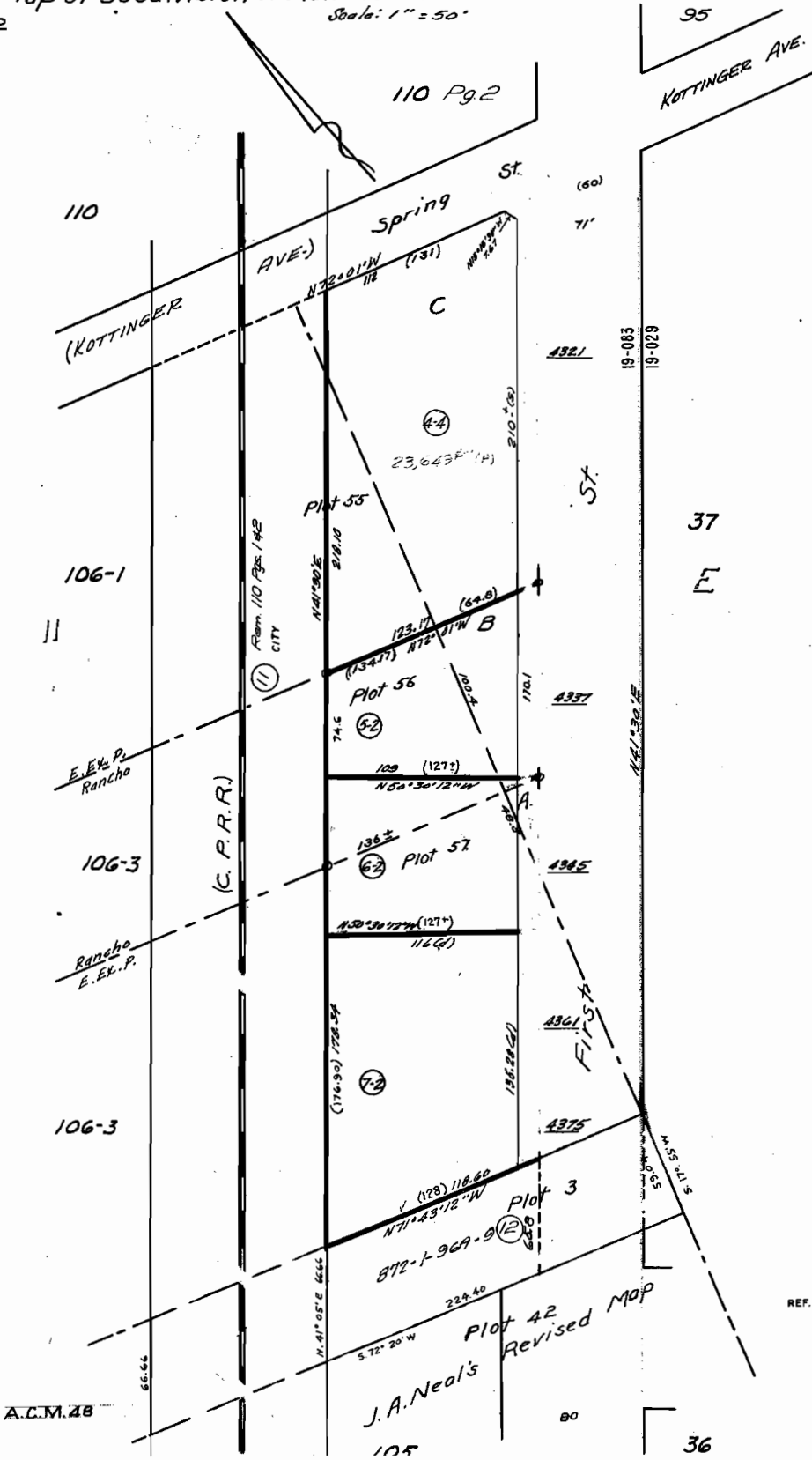
Map of Eastern Extension of Pleasanton (BL 7 Pg. 60)

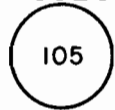

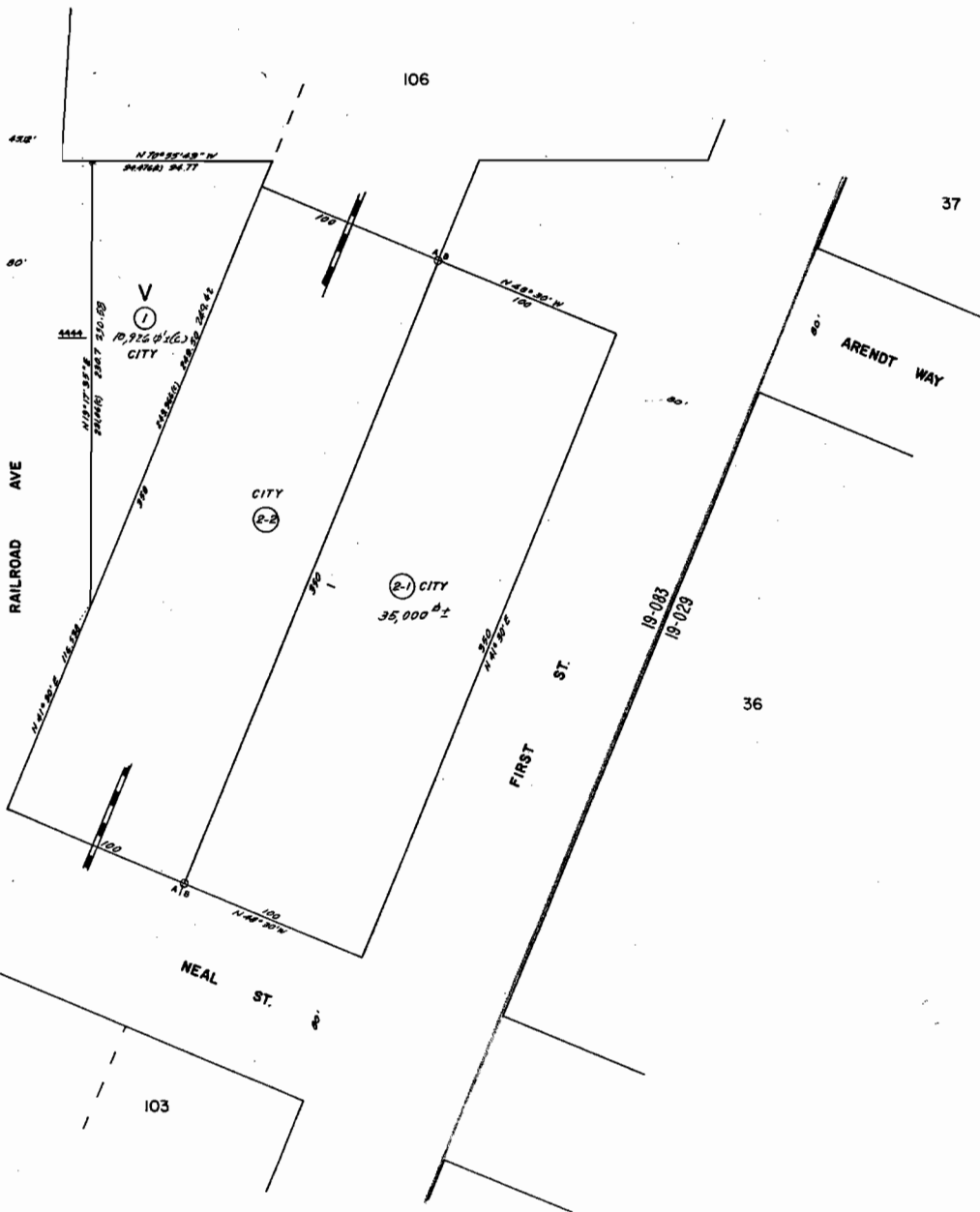
