Mark,

Thank you for briefly discussing the site today. We understand you plan to send out a directive letter in the near future requiring additional assessment. Pangea has been retained to address your concerns and to help with the Cleanup Fund application upon receipt of your directive letter.

FYI, attached is a photo of the former UST area and the two nearby residences. Due to the close proximity to the residences and the rocky subsurface, additional investigation could involve soil sampling, grab groundwater sampling (if any encountered before rocky material causes refusal during initial direct-push sampling), and soil gas sampling near each residence. One primary goal of the soil/water/soil gas sampling would be to help confirm that ethylbenzene or other compounds have not migrated in soil or within groundwater in fractured rock to the point where they pose a significant vapor intrusion concern.

We look forward to addressing your concerns in our pursuit of case closure.
