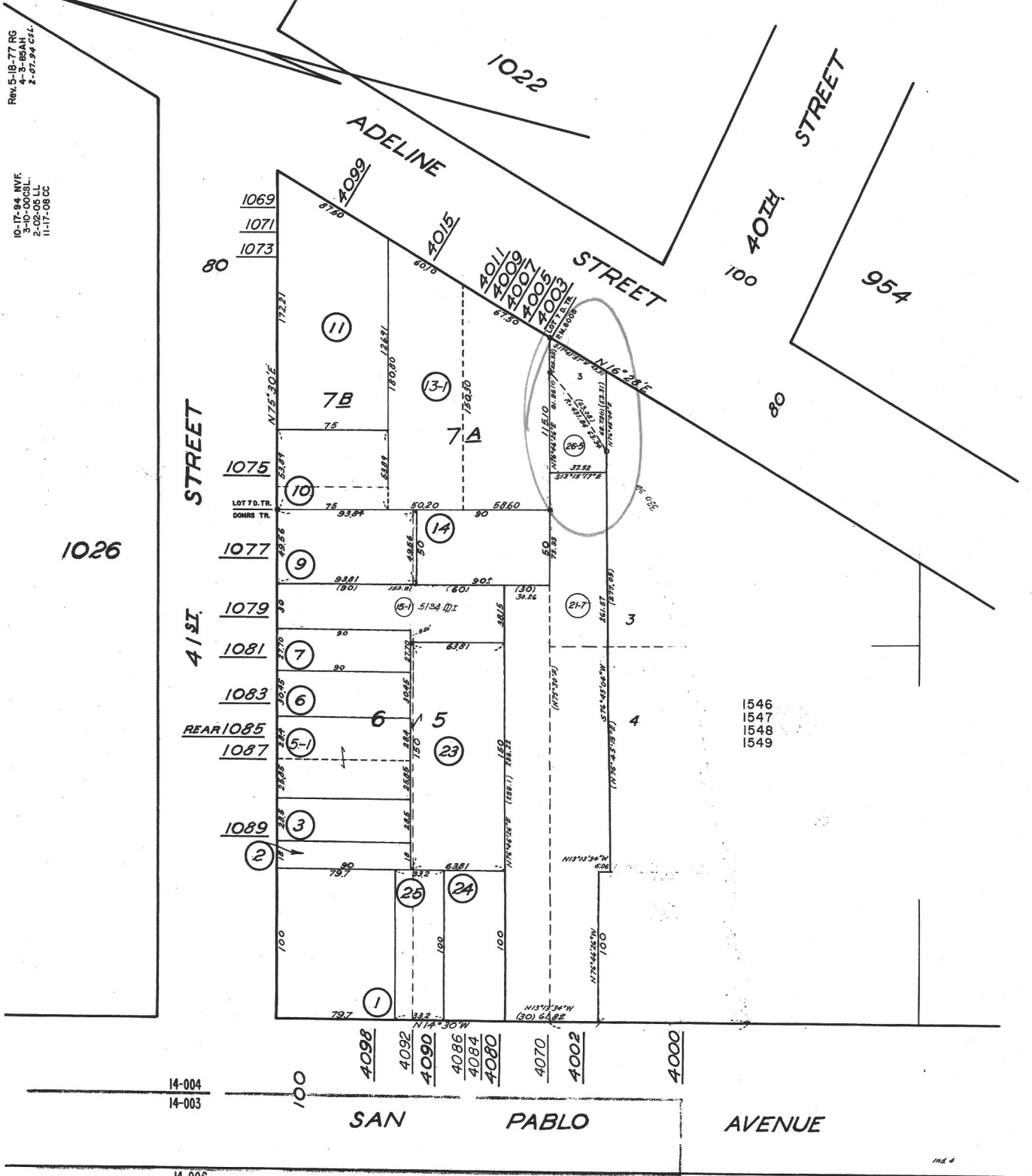
MAP OF LOT NO. 7 IN THE H. C. DOHR'S HOMESTEAD (Bk.19 Pg.2)
